A Presidential Preference Primary and County Primary (Republican) are hereby called for Stewart County, Tennessee, for Tuesday, March 5, 2024 for the offices listed below:

**President (Primary)**

Qualifying Deadline: December 5, 2023 at 12:00 NOON

Withdrawal Deadline: December 12, 2023 at 12:00 NOON

**President (Independent Candidates)**

Qualifying Deadline: August 15, 2024, 12:00 Noon

Withdrawal Deadline: August 22, 2024, 12:00 Noon

**Delegates**

Qualifying Deadline: December 14, 2023 at 12:00 NOON

Withdrawal Deadline: December 21, 2023 at 12:00 NOON

**County Primary (Republican)**

Assessor of Property

School Board Districts 2, 3, and 6.

**Qualifying Deadline: December 14, 2023 at 12:00 NOON**

This deadline applies to all County Primary candidates, including independent candidates.

**Withdrawal Deadline: December 21, 2023 at 12:00 NOON**

A candidate's request to withdraw must be in writing and filed with each of the counties where the candidate filed their nominating petition.

**Voter Registration Deadline: February 5, 2024.**

By mail applications must be postmarked by February 5, 2024. Any Stewart County resident needing to register to vote, change their name or change their address may do so online at govotetn.com. By mail voter registration applications are also available at all local USPS locations and the Public Library. To register or update a registration in person, visit the Stewart County Election Office.

**State ID Law:** Federal or Tennessee state government issued photo ID is now required to vote, unless an exception applies. College student IDs will not be accepted.
